Abstract

The purpose of this public notice is to bring to the attention of persons likely to be affected by the grant of the proposed licence for AC Automation (UK) Limited and to invite representations or objections in connection with it.

Audience

Persons likely to be affected by the grant the proposed licence referred to above.

Consumer impact

The Authority considers that the grant of the proposed licence would be an appropriate course of action for it to take. Such a grant is in keeping with the Authority's principal statutory objective in that it protects the interests of consumers of electricity supplied by authorised suppliers. This is done, wherever appropriate, by promoting effective competition between persons engaged in, or in commercial activities connected with, the generation, transmission, distribution or supply of electricity.

Pursuant to Article 10(4) of the Order the Northern Ireland Authority for Utility Regulation (the Authority), hereby gives notice as follows:

- 1 It proposes, in accordance with Article 10 (1) of the Order, to grant a licence to generate electricity to AC Automation (UK) Limited, a limited company having its registered office at 5 Sloefield Park, Carrickfergus, Co. Antrim, BT38 8GR (the "Proposed Licensee").
- 2 Such licences would enable the Proposed Licensee to operate as a Demand Side Unit Operator in the Single Electricity Market.
- The Authority considers that the grant of the proposed licence would be an appropriate course of action for it to take as such grant is in keeping with the Authority's principal statutory objective in that it protects the interests of consumers of electricity supplied by authorised suppliers, wherever appropriate by promoting effective competition between persons engaged in, or in commercial activities connected with, the generation, transmission, distribution or supply of electricity.
- The Authority further considers that the application made by the Proposed Licensee has been made in the prescribed manner and that the appropriate fee has been submitted.
- The purpose of this public notice is to bring to the attention of persons likely to be affected by the grant of the proposed licence referred to above and to invite representations or objections in connection thereto. Any representations or objections with respect to the proposed licence may be made **on or before 22 January 2016.**
