About the Utility Regulator

The Utility Regulator is the independent non-ministerial government department responsible for regulating Northern Ireland's electricity, gas, water and sewerage industries, to promote the short and long-term interests of consumers.

We are not a policy-making department of government, but we make sure that the energy and water utility industries in Northern Ireland are regulated and developed within ministerial policy as set out in our statutory duties.

We are governed by a Board of Directors and are accountable to the Northern Ireland Assembly through financial and annual reporting obligations.

Abstract

This paper sets out the UR's intention to grant a gas supply licence to EP NI Energy Limited.

In exercise of its powers under Article 8(4) of The Gas (Northern Ireland) Order 1996 ("the Order") the Northern Ireland Authority for Utility Regulation ("the Authority"), hereby gives notice as follows:

Utility Regulator

- It proposes, in accordance with Article 8(1) (c) of the Order, to grant a licence to supply gas to EP NI Energy Limited, a private limited company, established in Northern Ireland and having its principal place of business at Kilroot Power Station, Larne Road, Carrickfergus, Northern Ireland, BT387LX (the "Proposed Licensee").
- 2) The Authority considers that the grant of the proposed licence would be an appropriate course of action for it to take as such grant is in keeping with the Authority's principal statutory objective in that it promotes the development and maintenance of an efficient, economic and co-ordinated gas industry in Northern Ireland.
- 3) The Authority further considers that the application made by the Proposed Licensee has been made in the prescribed manner and confirms that the appropriate fee has been submitted.
- 4) The purpose of this notice is to bring to the attention of persons likely to be affected by the grant, the proposed licence referred to above and to invite representations or objections in connection thereto. Any representations or objections with respect to the proposed licence may be made on or before 19 March 2021 to:
