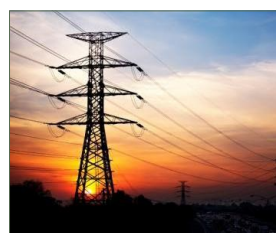


**PUBLIC NOTICE UNDER ARTICLE 10(4) OF THE

(the Order)**

About the Utility Regulator

The Utility Regulator is the independent non-ministerial government department responsible for regulating Northern Ireland's electricity, gas, water and sewerage industries, to promote the short and long-term interests of consumers.

Abstract

The purpose of this public notice is to bring to the attention of persons likely to be affected by the grant of the proposed supply licence and proposed generation licence for Powerhouse Generation Limited and to invite representations or objections in connection with it. The licensing framework to enable Demand Side Units to operate in the SEM was previously consulted on.

Audience

Persons likely to be affected by the grant the proposed licence referred to above.

Consumer impact

The Authority considers that the grant of the proposed licence would be an appropriate course of action for it to take. Such a grant is in keeping with the Authority's principal statutory objective in that it protects the interests of consumers of electricity supplied by authorised suppliers. This is done, wherever appropriate, by promoting effective competition between persons engaged in, or in commercial activities connected with, the generation, transmission, distribution or supply of electricity.

Pursuant to Article 10(4) of the Order the Northern Ireland Authority for Utility Regulation (the Authority), hereby gives notice as follows:

- 1 It proposes, in accordance with Article 10 (1) of the Order, to grant a licence to supply electricity and a licence to generate electricity to Powerhouse Generation Limited, a limited company having its registered office at The Courtyard, 62a Drumnabreeze Road, Magheralin, Co Armagh, BT67 0RH (the "Proposed Licensee").
- 2 Such licences would enable the Proposed Licensee to operate as a Demand Side Unit Operator in the Single Electricity Market.
- 3 The Authority considers that the grant of the proposed licences would be an appropriate course of action for it to take as such grant is in keeping with the Authority's principal statutory objective in that it protects the interests of consumers of electricity supplied by authorised suppliers, wherever appropriate by promoting effective competition between persons engaged in, or in commercial activities connected with, the generation, transmission, distribution or supply of electricity.
- 4 The Authority further considers that the applications made by the Proposed Licensee have been made in the prescribed manner and that the appropriate fee has been submitted.
- 5 The purpose of this public notice is to bring to the attention of persons likely to be affected by the grant of the proposed licences referred to above and to invite representations or objections in connection thereto. Any representations or objections with respect to the proposed licence may be made **on or before 13 April 2015**.
