

- Mid Antrim Reinforcement in Part 2 of Grid Development Process, stakeholder engagement ongoing, ECD 2029
- Omagh Dromore Uprate construction underway, ECD 2023
- Drumnakelly Tamnamore Uprate TNPP submitted, ECD 2029
- Moyle Reinforcement TNPP submitted, ECD 2027
- Cam substation extension TNPP being drafted
- North and West Reinforcement options report commencing shortly, ECD 2030
- Feeny Cluster SOP cancelled as developers to be offered direct connections
- Mid Tyrone Reinforcement stakeholder engagement complete TNPP costing underway, ECD 2029 at earliest
- Larne and Limavady tx uprate options papers underway, TNPP not required
- Coolkeeragh Strabane uprate optioneering underway
