

## **GAS NOTICE**

### Notice under Article 8(4) and Article 14(3) of the Gas (Northern Ireland) Order 1996

The Northern Ireland Authority for Utility Regulation (hereinafter referred to as the "Authority") pursuant to Article 8(4) and Article 14(3) of the Gas (Northern Ireland) Order 1996, as amended (the "Order") hereby gives notice as follows:

1. Pursuant to Article 8(2)(c) and Article 14(1)(a) of the Order respectively, the Authority proposes to make extensions (the "Extensions") and modifications (the "Modifications") to the gas supply licences held by the following companies under Article 8(1)(c) of the Order (each a "Supply Licence"): –

- (i) Phoenix Supply Limited
- (ii) Airtricity Energy Supply (NI) Ltd
- (iii) Power & Gas Ventures Limited
- (iv) VAYU Limited
- (v) Viridian Energy Supply Limited
- (vi) ONI Gas Limited
- (vii) ESB Independent Energy (NI) Ltd
- (viii) Firmus Energy (Supply) Ltd (Ten Towns Area)
- (ix) Firmus Energy (Supply) Ltd (Greater Belfast Area)

(together the "Affected Companies").

2. In respect of each of the Affected Companies other than Firmus Energy (Supply) Ltd, the Extension proposed by the Authority involves an extension to the premises to which each of the relevant Affected Companies may supply gas pursuant to its Supply Licence such that each relevant Affected Company may supply:
  - a. large Industrial & Commercial customers (>732,500kWh reasonably expected annual consumption) in the Ten Towns area from 1 October 2012; and
  - b. all customers in the Ten Towns area from 1 April 2015.
3. The reason for the proposed Extension is to implement and facilitate the two stages of market opening to occur in the Ten Towns area from October 2012 and April 2015 respectively.
4. In respect of each of the Affected Companies other than Firmus Energy Ltd, the Modification proposed by the Authority is to Schedule 1 of each of the Affected Companies' Supply Licences and involves removing the existing reference to the area map and/or to particular geographical areas and/or to particular premises and replacing it with a reference to the network within Phoenix Natural Gas Limited's gas conveyance licence under Article 8(1)(a) of the Order (the "Conveyance Licence").
5. The reason for the proposed Modification is to ensure that in the event that the Conveyance Licence has been extended under Article 8(2)(a) of the Order, the relevant gas suppliers in that area are automatically able to supply the relevant area or premises. This will ensure licensed areas are more consistent across the various licenses under the Order and will also save on the administrative costs associated with periodically extending the gas network to small areas or individual premises.

6. In respect of Firmus Energy (Supply) Ltd ("Firmus"), which already holds separate Supply Licences in respect of the Greater Belfast area and the Ten Towns area, the Modification proposed by the Authority is to Schedule 1 to each of Firmus' Supply Licences and involves the existing references to Electoral Wards and an area map in each Supply Licence being replaced with a reference to the appropriate gas conveyance licence.

9. The Authority has, pursuant to Article 14(4)(b) of the Order served a copy of this notice on the Licensee and sent a copy to the Department of Enterprise, Trade and Investment.
