

# Notice under Article 14(2) of the Gas (Northern Ireland) Order 1996 – Modifications Proposed to the Gas Conveyance Licence Held by firmus energy (Distribution) Limited

## THE NORTHERN IRELAND AUTHORITY FOR UTILITY REGULATION NOTICE UNDER ARTICLE 14(2) OF THE GAS (NORTHERN IRELAND) ORDER 1996 MODIFICATIONS PROPOSED TO THE GAS CONVEYANCE LICENCES HELD BY FIRMUS ENERGY (DISTRIBUTION) LIMITED

The Northern Ireland Authority for Utility Regulation ('the Authority') proposes to modify the conditions of a licence in exercise of the powers conferred on it by Article 14(1) of the Gas (Northern Ireland) Order 1996 ("the Order").

In accordance with Article 14(2) of the Order the Authority gives notice as follows:

1. The Authority proposes to make modifications to the gas conveyance licence ("the Licence") held by firmus energy (Distribution) Limited ("the Licensee").
2. The proposed modifications are to the conditions of the Licence as set out in Annex 1 to the attached consultation paper on Licence Modifications Pursuant to the GD17 Final Determination and other Regulatory Decisions.
3. Details of the proposed modifications are set out in chapters 2, 3, 4, 5, 7, 8 and 11 of the attached consultation paper on Licence Modifications Pursuant to the GD17 Final Determination and other Regulatory Decisions as well as in Annex 1 to that consultation paper.
4. The reasons for the proposed licence modifications are set out in chapters 2, 3, 4, 5, 7, 8 and 11 of the attached consultation paper on Licence Modifications Pursuant to the GD17 Final Determination and other Regulatory Decisions.
5. The effects of the proposed licence modifications are set out in chapters 2, 3, 4, 5, 7, 8 and 11 of the attached consultation paper on Licence Modifications Pursuant to the GD17 Final Determination and other Regulatory Decisions.


