**Request for Authority's consent to further defer Connection Offer Timelines to Issue a Connection Offer for Connection Application at Tardree Forest Wind Farm, NIE Networks reference 16/11559.**

Thank you for your correspondence of 16 April 2018 requesting consent from the Authority for NIE Networks to extend the required three month timeline to issue a connection offer to **Tardree Forest Wind Farm**, Connection Application.

**NIE Network's request for further connection offer extension**

NIE Network's asks for a further extension for this connection offer to 30/04/2019 under Condition 30 paragraph 4 of the NIE Networks Distribution licence.

NIE Networks has commented that it will issue a new connection policy process on 04/05/2018 and this will take effect two weeks later on 18/05/2018 and that a further extension of time is requested for this application in order to provide the applicant with sufficient time to consider the imminent new NIE Networks Generation Connections Policy that follows stakeholder feedback gained through the joint Consultation on Connecting Further Generation in Northern Ireland<sup>1</sup>.

The specific policy measures that aim to prevent capacity will be of particular interest to the applicant and require consideration prior to proceeding with a connection offer.

We also note that this project does not have planning permission the suggested Transmission Connection Node for this application is via the proposed Kells cluster. NIE Networks have also commented that under the imminent NIE Networks policy change and subject to no existing applicants withdrawing in the interim, this application would be queued outside of the 90 MW capacity limit at Kells Cluster and will be ineligible for a connection offer in the short term. This status will be clarified when the new connections policy comes into effect.

NIE Networks has consulted both verbally and via written correspondence and the applicant in question has consented to the proposed extension.

## **The Authority's decision**

The relevant section of the distribution licence is within Condition 30. This requires a connection offer to be made not later than 3 months unless consent to a longer period has been approved by the Authority.


Having considered your correspondence and reviewed the response from the connection applicant in question, the Authority is able to agree to the extension period requested to 30/04/2019.

We wish to remind NIE Networks that we remain of the view that granting of extensions should be the exception rather than the norm, and so NIE Networks should be mindful of this if considering further extensions in the future

This extension letter will be published on our website; we will also keep a record of the information and decision on the Public Electricity Register as required by the Electricity (Northern Ireland) Order 1992.

We ask to be kept informed of progress.
