

# **Decision published pursuant to Article 14(8) of the Electricity (Northern Ireland) Order 1992 – Modifications to Annex 2 of the Transmission Licence Held by Northern Ireland Electricity Networks (Ltd)**

## **THE NORTHERN IRELAND AUTHORITY FOR UTILITY REGULATION NOTICE UNDER ARTICLE 14(8) OF THE ELECTRICITY (NORTHERN IRELAND) ORDER 1996 MODIFICATIONS TO THE ELECTRICITY LICENCE HELD BY NORTHERN IRELAND ELECTRICITY NETWORKS**

In accordance with Article 14(2) of the Electricity (Northern Ireland) Order 1992 (the “Electricity Order”) the Northern Ireland Authority for Utility Regulation (“the Authority”) published a notice of its intention to modify the conditions of the Transmission Licence (“the Licence”) held by Northern Ireland Electricity Networks (Ltd) (“the Licensee”)

In accordance with Article 14(5) of the Electricity Order the Authority has considered representations duly made to it. The Authority has decided to proceed with the making of modification of the conditions of the Licence in exercise of its power under Article 14(1) of the Electricity Order.

In accordance with Article 14(8) of the Order the Authority gives notice as follows:

1. The modifications are to the conditions of the Licence as set out in Appendix 1 to the attached decision paper on Licence Modifications Pursuant to the RP6 Final Determination and other Regulatory Decisions.
2. Details of the modifications are set out in chapters 2, 3, 4, 5, 6, 7, 8, and 9 of the attached decision paper on Licence Modifications Pursuant to the RP6 Final Determination.
3. The reasons for the licence modifications are set out in chapters 2, 3, 4, 5, 6, 7, 8, and 9 of the decision paper on Licence Modifications Pursuant to the RP6 Final Determination.
4. The effects of the licence modifications are set out in chapters 2, 3, 4, 5, 6, 7, 8, and 9 of the decision paper on Licence Modifications Pursuant to the RP6 Final Determination.
5. The Authority has, pursuant to Article 14 (8) (a), published this notice on its website. In addition the Authority has sent a copy of this notice to the Licensee, the Department for Economy and also to the General Consumer Council for Northern Ireland.
6. This decision will be effective from, 2 October 2017, 56 days after the publication of this decision.
