1 MINUTES OF THE PREVIOUS MEETING

The Authority formally agreed the minutes of the previous meeting.

2 WATER REFORM PROGRESS

Overview

OFREG gave a general overview of previous information submitted to Authority members. OFREG stated that the Department for Regional Development had a team

already working on Water Reform and fully appreciates the significant future role the Authority is expected to play next year.

Complaints & Compliance

The Authority learned that the General Consumer Council Northern Ireland is intended by DRD to still be the body to deal with overall complaints after the customer has exhausted DRD's Go-co's complaints handling procedure as a first means of redress (for water related problems). However, the Authority would need to put in place a complaints handling process, which may be required by the legislation. Ofreg has been in discussion re: the complaints handling issue with Ofwat and good relationships are starting to be formed.

3 ALL ISLAND PROJECT

(A) Progress Report

A Progress Report had been distributed to the Authority Members in advance of the meeting. A general discussion followed without any action points to note.

(B) Presentation on Modelling by ILEX

An employee from ILEX joined the meeting and gave a Presentation.

4 NIE PRESENTATION PPB/SUPPLY POST SEM
