**Market Power Mitigation in the SEM**

**Decision to Suspend the Directed Contract  
Subscription Windows**

On 24<sup>th</sup> April 2009 the Regulatory Authorities (RAs) published an SEM Committee Decision Paper on the Quantification and Pricing of Directed Contracts (DCs) for the 2009/10 contracting year (SEM-09-043).<sup>1</sup> This paper followed the completion of the SEM Plexos validation project and DC implementation workstream. The results of the SEM Plexos model validation project were presented at an industry workshop on Friday 17<sup>th</sup> April 2009.

As per the SEM Committee timetable (SEM-09-041), the DC primary subscription window commenced on Tuesday 5<sup>th</sup> May 2009 and is due to close on 3<sup>rd</sup> June 2009, and the supplemental subscription window is scheduled to open on 8<sup>th</sup> June 2009 and close on 19<sup>th</sup> June 2009.

Through ongoing work with Energy Exemplar, the developers and owners of the Plexos software, and our independent consultants, KEMA, the RAs have been advised that there have been material errors made in the backcast work by our independent consultants. On this basis, KEMA have advised that the errors in their validation work calls into question the accuracy of the forecast prices advised to the RAs and contained in SEM-09-043.

In light of this information, the RAs have also been advised by our consultants, KEMA, that it would be appropriate to review their model validation exercise and suspend the DC subscription process. A note from KEMA on this issue will be published shortly

On this basis, the SEM Committee has decided that it is necessary to suspend the DC subscription process with immediate effect, until remedial action is taken to thoroughly review the validation exercise undertaken on their behalf. The SEM Committee want this suspension to last for as short a period as possible and will issue a revised DC timetable soon. In the meantime, the SEM Committee expect that Non Directed Contracts (NDCs) will be offered by the incumbent generators.
