Guidance

This table has three blocks and a total of 10 lines. It covers:

Properties

Includes a breakdown of all measured and unmeasured households and non-household properties, including an analysis of the totals connected to the sewerage system and those receiving treatment. These figures should be an average for the report year.

Domestic includes domestic drainage of factories, offices, commercial premises and households; and excludes trade effluent.

A property is defined as being the subject of a separate sewerage charge, and being occupied as a domestic household, or used for public, commercial or industrial purposes.

Where a property is uneconomic to bill (for example lock-up garages) they should not be included in the data reported in this table. Instead, please report the number of these properties in your commentary.

Population

This records the total connected population which comprises resident and non-resident population. In calculating total population NI Water will need to estimate its non resident population. Non-resident population should include holiday and tourist population. The company is to include in the commentary a statement detailing the estimation method used including the date of the data on which the estimate is made. An acceptable method would be to obtain from the tourist board estimates of the number of bed spaces available for non-residents. Except where there is firm evidence to the contrary, undertakers should assume a two-thirds occupancy rate for four months in the year. Where there is such evidence, it should be stated in the commentary. NI Water should not include any allowance for daily commuters or day visitors.

Population figures should be consistent with NISRA estimates of mid year resident population, which are based upon the latest available census returns. Population figures should only differ from NISRA estimates where such differences are based on sound evidence. Where there is such evidence, it should be stated in the commentary. An acceptable method for deriving the sewerage connected population would be to pro-rate the total population connected for water by the proportion of water households that are also billed for sewerage. Where other methods have been adopted, this should be stated in the commentary.

For definition of household and non-household see Chapter 7.

The information in this table is used for the sewage collected unit cost analysis, and Principal Statements and associated additional information (for tariff and charging issues). NI Water must include inset appointments as they are part of the regulated business.

Provision of sewerage service to Billed Customers

Where reference is made in tables to 'billed household and billed non-household', this should be taken as the provision of sewerage services to customers whether they are billed directly (non-domestic customers) or payment is made by DRD on their behalf as a third party consideration (domestic and non-domestic customers).



- NI Water to provide customer numbers for metered non household connected properties for the sewerage service as at 1st April 2012 and 31st March 2013.
- NI Water to provide customer numbers for 'billable' metered non household connected properties for sewerage service as at 1st April 2012 and 31st March 2013 in the event of them differing from connected property numbers.
- Basis and rationale for calculating financial year customer numbers i.e. average of year start and end values, midpoint, etc.
