

# Notice of decision to modify the gas supply licence held by Flogas Natural Gas Limited

11 February 2016

## NOTICE UNDER ARTICLE 14(8) OF THE GAS (NORTHERN IRELAND) ORDER 1996

In pursuance of its powers under Article 14(1) of the Gas (Northern Ireland) Order 1996 (as amended) (the "Order") and having obtained the consent of the Licensee, the Northern Ireland Authority for Utility Regulation (hereafter referred to as the "Authority") hereby gives notice under Article 14(8) as follows:

- 1 The Authority will modify the gas supply <u>licence</u> (the "Licence") held by Flogas Natural Gas Limited (the "Licensee"), a company established in Northern Ireland and having its principal place of business at Airport Road West Sydenham, Belfast, BT3 9ED.
- The modification will amend the financial year in condition 1.2 of the licence. The financial year in the licence was 1 January to 31 December each year. The modification will change the financial year to run from 1 April to the following 31 March.
- 3 The reason for the modification is to align the financial year in the licence to Flogas Natural Gas Limited's own statutory financial year. The modification was requested by the licensee.
- The Authority considers that this modification to the licence is an appropriate course of action in order to align the financial year with the licensee's own statutory reporting period of 1 April to 31 March. The Authority considers that the proposed modification will not have any effect on any other energy supplier or on the Northern Ireland retail energy market.
- On 16 December 2015, the Authority published a <u>notice</u> stating that it intended to modify the licence and giving the reasons and effect of the modification. The purpose of this notice was to bring the proposed modification to the attention of persons likely to be affected by it, and to invite representations or objections in connection thereto. We did not receive any representations or objections related to this notification.
- The Authority will therefore implement the modification, as proposed in the notice dated 16 December 2015. The modification will take effect from 8 April 2016.

7 The modification is set out below:

In Condition 1.2 of the licence, existing paragraph 1.2.1 shall be substituted as follows:

#### "1.2.1 Financial years

For the purposes of this Condition the first financial year of the Licensee shall run from the date of the Grant to 31st December 2014. Thereafter each financial year of the Licensee shall run from 1st April to the following 31st March."
