NOTICE UNDER ARTICLE 8(6) OF THE **GAS (NORTHERN IRELAND) ORDER 1996**

Pursuant to Article 8(6) of The Gas (Northern Ireland) Order 1996 ("the Order") the Northern Ireland Authority for Utility Regulation ("the Authority"), hereby gives notice as follows:

- The Authority, in accordance with Article 8(2)(a) of the Order, has granted an extension to the licence to supply gas (the "Licence") held by SSE Airtricity Gas Supply (NI) Limited¹ (the "Licensee") by increasing the authorised area of the Licence.
- 2) The authorised area is set out in Schedule 1 of the Licence and this area has been extended to include the West Area. The West Area means the licensed area within Schedule 1 of the Scotia Gas Networks Conveyance licence².
- 3) The extension will allow the Licensee an opportunity to supply gas to customers within the West Area when the network in the West Area has been developed.
- 4) The Authority considers that granting the extension is an appropriate course of action for it to take, as such grant is in keeping with the Authority's principal statutory objective to promote the development and maintenance of an efficient, economic and co-ordinated gas industry in Northern Ireland.
- 5) On 6 May 2016, the Authority published a notice, under Article 8(4) of the Order, of its intention to extend the licence. The Authority asked for any representations or objections with respect to the proposed extension to be made on or before 8 June 2016 2016. We did not receive any responses.
- 6) A copy of the extended Schedule 1 of the Licence is appended to this notice (see Annex 1). The consolidated licence is also available to view on our website.
- 7) The Authority has sent a copy of this notice to the Licensee, the Department for the Economy and the Consumer Council.

SCHEDULE 1

Designated Area and Premises

- The premises designated as a term of the licence in this Schedule 1 are any person or premises:
 - (a) in the Greater Belfast Area;
 - (b) in the Ten Towns Area; and
 - (c) in the West Area.

2 In this Schedule:

"BGE Conveyance Licence" means the Licence for the Conveyance of Gas granted to Bord
Gais Eireann by the Authority pursuant to Article 8(1)(a) of the
Order;

"Greater Belfast Area" means the Licensed Area within Schedule 1 of the Phoenix Conveyance Licence;

"Phoenix Conveyance means the Licence for the Conveyance of Gas granted to Licence" Phoenix Natural Gas Limited by the Authority pursuant to Article 8(1)(a) of the Order;

"Scotia Gas Networks means the Licence for the Conveyance of Gas granted to Conveyance Licence" Scotia Gas Networks Northern Ireland Ltd by the Authority pursuant to Article 8(1)(a) of the Order;

"Ten Towns Area" means the Licensed Area within Schedule 1 of the BGE Conveyance Licence.

"West Area" means the Licensed Area within Schedule 1 of the Scotia Gas

Networks Conveyance Licence.
