Section B8 – Revenue and tariffs

Section 8 contains 15 tables that analyse Northern Ireland Water's revenue into constituent components. It links closely with 'Section 7: Finance' and includes inputs into the financial model. Northern Ireland Water should therefore ensure that the assumptions and outturns in Section B8 are consistent with Section B7. A commentary should accompany all tables and a description included of any assumptions made therein.

It should be noted that NIAUR proposes to utilise the B8 tables as the basis for an IPS capture system and would welcome NI Water commentary on this proposal.

Table 1 provides a summary of Northern Ireland Water's revenue, breaking it down in two ways:

5 **Tariff baskets**, which are the level at which price limits are set and allow flexibility in pricing for the 2010-14 review and

10 Revenue Groupings which are used to analyse cross-subsidy.

The following tables B8-2 to B8-12 set out the tariffs, tariff multipliers and revenue for each of the revenue groups. Northern Ireland Water should set out the detail of each of these for 2007-08 and forecasts for 2008-09 to 2016-17. The tables reflect the existing tariff structure and the company should use its best estimates to forecast changes to the tariff level, tariff multipliers and tariff revenue:

Customer numbers - these should be average numbers in accordance with Table 7 of the Annual Information Return 2008 definitions.

□ **Tariff multipliers** are the unit (e.g. consumption) by which the tariff is multiplied to generate revenue.

□ **Tariffs** are the annual tariff (unit rate charge) for the service (e.g. standing or volumetric charges); and

□ **Revenue** is the product of the tariff multiplier and the tariff.

Tariff multipliers Northern Ireland Water should set out the actual tariff multipliers for 2007-08 and forecast these to 2016-17. In forecasting tariff multipliers, the company should ensure it includes projections of the underlying growth of the customer base and the effects of any Ministerial guidance for the 2010-12 period.

Explanations of these assumptions should be set out in commentary to the tables. Northern Ireland Water should summarise the key aspects of its forecast charges affecting domestic and non-domestic customers. It should identify and substantiate changes in the customer base, cross-referencing with evidence provided in other parts of the business plan and providing further evidence as appropriate. Northern Ireland Water should also include an explanation of any material year-on-year variances in any of the assumptions. The company should ensure that its projections of volumes and properties are consistent with base assumptions on properties, volumes and population; and with other plan information and assumptions on Supply/Demand.

The company should input revenue relating to the particular charges and customer irrespective of how this is funded - whether through subsidy or direct charging. Revenue per tariff is therefore independent of any current or proposed funding arrangements.

Tariffs - Northern Ireland Water should enter 2007-08 and 2008-09 actual tariffs. It should also project tariffs for each year to 2016-17. It should input all tariffs in projected outturn prices, consistent with the inflation assumptions in the rest of the Business Plan.

Trade Effluent – The company should provide input on the volume of trade effluent, the standards sewage strengths, the weighted average trade effluent strengths and the relevant tariffs (as per Mogden i.e. R, V, B and S). The company should then report the total revenue generated from trade effluent discharge.

(The NIAUR financial model projects revenue assuming uniform tariff increases across all tariffs within a revenue group. If Northern Ireland Water wishes to analyse the impact of rebalancing tariffs within a revenue group, it should input these alternative tariffs in this Section and explain in the commentary how these relate to NIAUR financial model tariffs.)

Revenue - Revenue is normally calculated automatically as the product of tariff multipliers and tariffs. Northern Ireland Water should explain in its commentary the impact of:

□ any demand forecasts for the service;

□ any relative change in price due to changes in the cost of providing a service (e.g. greater efficiency); and

□ any relative change in price or revenue due to the unwinding of cross-subsidy or mis-apportionment.

Full explanations must be given for revenue totals which are not the product of tariff multipliers and tariffs.

It is assumed in the tables that there are no trade effluent charges for large user customers.

Table B8-13 summarises new connections and meters for household and non households.

Tables B8-14 and 15 report on third party contributions to capital expenditure.

Guidance to Reporter The Reporter should:

□ Confirm or otherwise that the base year information is consistent with other published / audited information, and, where appropriate, billing records;

□ Scrutinise, and provide an assessment of any explanations provided by Northern Ireland Water for discrepancies;

□ Comment on the material assumptions employed by Northern Ireland Water;

□ Scrutinise, and provide an assessment of the basis presented by Northern Ireland Water for assumptions of the number of properties, discount status and demand;

□ Comment on the match between demand forecasts and other information in the Business Plan on Supply/Demand;

□ Comment on the basis for the assumptions employed in forecasting large user/industrial demands

□ Provide an assessment of any explanations provided by Northern Ireland Water where discrepancies are identified with other parts of the plan.
